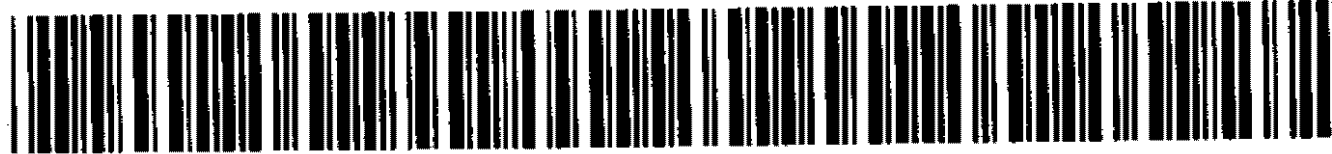

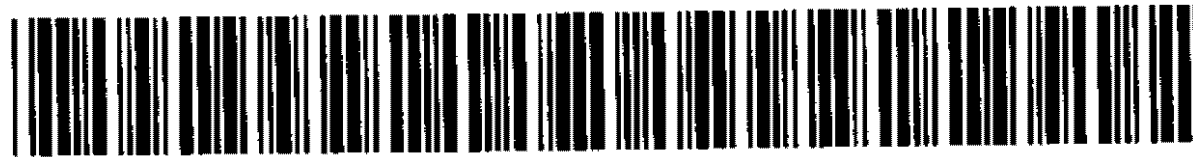

**NOTICE IS HEREBY GIVEN:**


