NOTICE IS HEREBY GIVEN:



The City of Santa Clarita, a municipal corporation, is the owner in fee, except for the right-of-way upon which it has been constructed, of a certain public improvement known as the Asphalt Roadway Rehabilitation Project Phase I and II, Projects M0072 and M0073, Federal-Aid Projects ESPL-5450 (48 and 50).
2. The City's address is 23920 Valencia Boulevard, Suite 300, Santa Clarita, California 91355.
3. The general locations of said public improvements are Soledad Canyon Road in the Canyon Country area and McBean Parkway in the Valencia area, within the City.
4. A contract to construct said public improvement was awarded to Sully-Miller Contracting Company, 1100 E. Orangethorpe Avenue, Suite 200, Anaheim, California 92801.
5. Work under said contract was completed on April 26, 2010, to the satisfaction of the City Engineer, and was accepted by the City on July 13, 2010.




