

NOTICE IS HEREBY GIVEN:


1. The City of Santa Clarita, a municipal corporation, is the owner in fee, except for the right-of-way upon which it has been constructed, of a certain public improvement known as Magic Mountain Parkway/Interstate 5 Interchange Landscape Beautification Phase II, Project S1003.
2. The City's address is 23920 Valencia Boulevard, Suite 300, Santa Clarita, California 91355-2196.
3. The general location of said public improvements is Magic Mountain Parkway 300 feet west of The Old Road to Tourney Road and The Old Road from Skyview Lane to 700 feet south of Shopping Center.
4. On May 25, 2010, a contract to construct said public improvement was awarded to Marina Landscape, Inc., 1900 S. Lewis Street, Anaheim, CA 92805-6621.
5. Work under said contract was completed on January 10, 2011, to the satisfaction of the City Engineer, and was accepted by the City on February 22, 2011.
