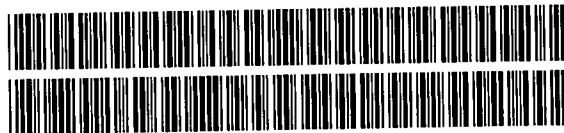

5. Work under said contract was completed on December 20, 2012, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.


