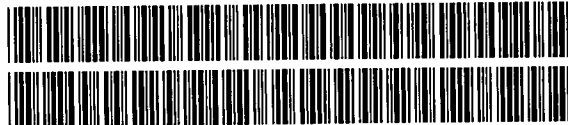




NOTICE IS HEREBY GIVEN:

5. Work under said contract was completed on March 15, 2013, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.
