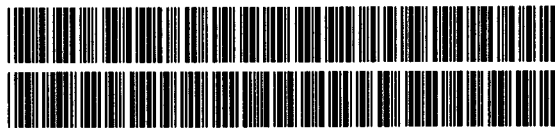




1. The City of Santa Clarita (City), a municipal corporation, is the owner in fee, of a certain public improvement known as City Hall Access Improvements, Project F1021.
