

NOTICE OF COMPLETION

NOTICE IS HEREBY GIVEN:

1. The City of Santa Clarita, a municipal corporation, is the owner in fee, except for the right-of-way upon which it has been constructed, of a certain public improvement known as Highway Safety Improvement Program Seco Canyon Road at Pamplico Drive, Orchard Village Road at Wiley Canyon Road, and Soledad Canyon Road at SR-14 Southbound ramps, Project Number C0043.
2. The City's address is 23920 Valencia Boulevard, Santa Clarita, California 91355-2196.
3. The general location of said public improvement is at the intersections of Seco Canyon Road and Pamplico Drive, Orchard Village Road and Wiley Canyon Road, and Soledad Canyon Road and SR-14 Southbound ramps in the City of Santa Clarita.
4. On May 23, 2017, a construction contract for said public improvement was awarded to Toro Enterprises, Inc., P.O. Box 6285, Oxnard, CA 93031.
5. Work under said contract was completed on February 2, 2018, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.
