NOTICE OF COMPLETION

1. The City of Santa Clarita, a municipal corporation, is the owner in fee, except for the right-of-way upon which it has been constructed, of a certain public improvements known as Fiscal Year 2014-15 Bridge Preventative Project Number M0101.
2. The City's address is 23920 Valencia Boulevard, Suite 120, Santa Clarita, California 91355-2196.
3. The location of said public improvements included the bridges on Valencia Boulevard S. over So. Fork Santa Clara River, Bouquet Canyon Road over Santa Clara River, Centurion Way over Bouquet Canyon Channel, Urbandale Avenue over Bouquet Canyon Channel, and Sierra Highway over Solemint Southern Pacific Railroad.
4. On September 26, 2017, a contract to construct said public improvement was awarded to Peterson Chase General Engineering Construction, Inc., 16351 Construction Circle West, Irvine, CA 92606.
5. Work under said contract was completed on September 12, 2018, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.
