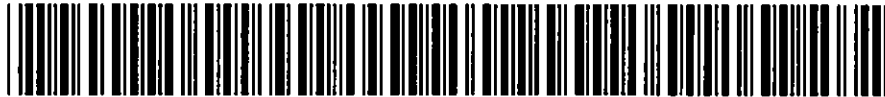



5. Work under said contract was completed on January 24, 2014, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.




