

2. The City's address is 23920 Valencia Boulevard, Santa Clarita, California 91355-2196.
3. The general location of said public improvement is on Lost Canyon Road from the intersection of Via Princesa, to 620' north of the intersection of Medley Ridge Drive, and at the intersection of Lost Canyon Road and Soledad Canyon Road, in the City of Santa Clarita.
4. On July 10, 2018, a construction contract for said public improvement was awarded to International Line Builders, Inc., 2520 Rubidoux Boulevard, Riverside, CA 92509.
5. Work under said contract was completed on January 30, 2019, to the satisfaction of the City Engineer, and the City hereby accepts the project as complete.


