Example 1.) Apartment complex (60 units) in Valencia District = Units x Factor x Rate = 60 x 0.7 x \$25,910 = \$1,088,220
 Example 2.) Shopping Center (7 gross acres) in Eastside District = Gross Acres x Factor x Rate = 7 x 5.0 x \$19,980 = \$699,300

Notes:

- If there is a question regarding which factor to use for residential development, refer to the underlying zoning.
- A zoning designation of OS (open space) is not subject to B&T District Fee
